1. When each pick-up form has been completed, they are to be emailed to Sea Swift Customer Service: - customerservice@seaswift.com.au . Customer Service will allocate a pick-up number and advise the customer.
2. Cut off time is **2.00pm Friday the week prior to pick up** for Aurukun and Lockhart River, Fitzroy Is, Green Is, Lizard Is, Cape Flattery, Haggerston Is, Hicks Is, Badu, Boigu, Coconut, Darnley, Dauan, Hammond, Kubin, Mabuiag, Murray, Saibai, St Pauls, Yorke, Yam, and Warraber Islands and remote depots – Horn Island, Thursday Island, Seisia and Weipa. Vehicle and machinery pickups from remote depots **must** be booked at least one week prior to travel.
3. Please note the completed forms are to have:
 - a) Order Numbers if required.
 - b) Weight and measurements.
 - c) Noted heavy items.
 - d) Vehicle registrations and if not drivable this must be noted.
 - e) Torres Strait Islands Biosecurity Approval arranged
 - f) Phone Numbers of both parties
 - g) IBC's must have IBC number.
 - h) Containers must have container number
4. Essential services will be given priority. There are no guarantees to be made of a pick-up date unless signed off by an Operations Manager.
5. Pickup and delivery will be from/to the ramp unless prior supplier arrangements have been made.
